A. General Provisions

1. Definitions

- (a). "Affiliate(s)" means an individual or an entity that directly or indirectly controls, is controlled by, or is under common control with the Consultant.
- (b). "Applicable Guidelines" means the policies of the Development Partner (DP) governing the selection and Contract award process, in case of DP funded project. "Applicable Law" means the laws and any other instruments having the force of law in Nepal as they may be issued and in force from time to time.
- (c). "Borrower [or Recipient or Beneficiary]" means the Government, Government agency or other entity that signs the financing [or loan/credit/grant/project] agreement with the Development Partner.
- (d). "Client" means the [procuring entity/Implementing/ executing agency] that signs the Contract for the Services with the selected Consultant.
- (e). "Consultant" means a legally-established professional consulting firm or an entity that may provide or provides the Services to the Client under the Contract.
- (f). "Contract" means a legally binding written agreement signed between the Client and the Consultant and includes all the attached documents listed in its Clause 1 (the General Conditions of Contract (GCC), the Special Conditions of Contract (SCC), and the Appendices).
- (g). "Data Sheet" means an integral part of the Instructions to Consultants (ITC) Section 2 that is used to reflect specific assignment conditions to supplement, but not to over-write, the provisions of the ITC.
- (h). "Day" means a calendar day.
- (i). "Development Partner (DP)" means the country/institution funding the project as specified in the Data Sheet.
- (j). "Experts" means, collectively, Key Experts, Non Key Experts, or any other personnel of the Consultant, Sub-consultant or Joint Venture member(s).
- (k). "Government" means the government of the Nepal.
- (l). "Joint Venture (JV)" means an association with or without a legal personality distinct from that of its members, of more than one Consultant where one member has the authority to conduct all business for and on behalf of any and all the members of the JV, and where the members of the JV are jointly and severally liable to the Client for the performance of the Contract.
- (m). "Key Expert(s)" means an individual professional whose skills, qualifications, knowledge and experience are critical to the performance of the Services under the Contract and whose CV is taken into account in the technical evaluation of the Consultant's proposal.
- (n). "ITC" (this Section 2 of the RFP) means the Instructions to Consultants that provides the shortlisted Consultants with all

 - (aa) deliberately destroying, falsifying, altering or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a GoN/DP investigation into allegations of a corrupt, fraudulent, coercive or collusive practice; and/or threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
 - (bb) acts intended to materially impede the exercise of the GoN's/DP's inspection and audit rights provided for under Clause GCC 25.2.
- b. will reject a proposal for award if it determines that the consultant recommended for award has engaged in corrupt or fraudulent activities in competing for the contract in question;
- c. will cancel the consultant's contract if it at any time determines that corrupt or fraudulent practices were engaged in by representatives of the consultant or the Client during the selection process or the execution of that contract;
- d. will blacklist a consultant for a stated period of time, to be awarded a contract if it at any time determines that the consultant has engaged in corrupt or fraudulent practices in competing for, or in executing, a contract; and
- e. will have the right to require that, a provision be included requiring consultants to permit the Client to inspect their accounts and records relating to the performance of the contract and to have them audited by auditors appointed by the Client.

1 Background

Town Development Fund (TDF) is based on policies for development, construction and operation of urban infrastructure to invest for the development, construction and operation of urban infrastructure, to invest on the basis of geographical area, institutional governance and strategic location, debt utilization and ability to pay. TDF focuses on preparing an investment project bank, and also providing technical support for potential project development, construction and operation. The fund allocates its investment in urban infrastructure from various sources such as capital received from the Government of Nepal, which are either in form of loans or grants to invest in the Urban Infrastructure Development Project (UIDP) projects. The TDF has following areas of infrastructure investment: (Based on Section 5, Annex 1)

Basic social infrastructure

- Land Pooling Project Smart City, Housing Plan, Integrated Settlement Urban Rehabilitation Project, Cultural and Archaeological Heritage Site House Pulling and other urban development infrastructure.

2 Preface

The works will be undertaken on behalf of the client Damak municipality hereafter refer as Client (Damak) and fund for the works will in part be obtained from the Town Development Fund(TDF) herein refer as employer.

Project implementation is monitored by the TDF. For the purpose of the works' execution, funds and contract administration will be carried out by the TDF and Damak Municipality. The municipality will designate in writing a Project Officer, who will be in charge for the project.

For the consulting services, the client (Damak) shall have to bear at least 30% of total service cost as matching fund while the remaining cost (70% of total cost) shall be finance by TDF.

3 Objective of Consulting Service

The objective of consulting service are to assist the client to implement the project "Damak Shopping Complex" are as follow:

1. To ensure high standards of quality assurance in the execution of work and completion of work within stipulated time period;
2. Comprehensive supervision of project implementation activities carried out by the Contractor to ensure complete compliance with the drawings, technical specifications and various stipulations contained in the Contract Documents;
3. Efficient construction supervision by personnel who are experienced in modern methods of construction supervision and contract management;
4. Act independently and on behalf of TDF and municipality to review all activities associated with Construction to ensure compliance of requirements of Contract Agreement in order to have a sound Project;
5. Report to TDF and Client on the financial and technical aspects of the project;
6. Assist the Client in arriving at an amicable settlement of dispute if any, occur during project implementation;

The Secondary objective is to assist the Client for effective project monitoring by providing project management and monitoring support.

4 Purposes of the Services

The services to be rendered by the Consultant encompass of following purposes:



- **Supervise:**
On behalf of the Municipality, such that the construction works are executed by the contractor in accordance with the provisions of the construction contract concluded between the contractor and the Municipality
- **Facilitate:**
On behalf of the employer, the municipality and the contractor such that both can take timely decisions and actions required under the construction contract
- **Monitor:**
On behalf of the Employer for overall construction contract implementation such that the project is completed within the scheduled time and cost frame with quality assurance.

5 PHASING AND LOCATION FOR CONSULTANT SERVICES

In the Consultant services to be rendered, three phases of work can be distinguished. Together with the locations, where the particular services have to be rendered, the phases are as follows:

6 PROCEDURE AND AUTHORITY LEVEL

The Consultant shall carry out the services as defined in the TOR or as otherwise required for efficient works' execution, while acting in the capacity of the "Engineer" according of the intentions of the "Conditions of Contract", which form part of the tender/contract documents for works' execution by the Contractor and are available for review at the Town Development Fund at the time of the pre-bid meeting. The mentioned "Conditions of Contract" describe in detail the duties and authorities of the Engineer and of the Engineer's Representative, to whom the Engineer may delegate duties and authorities as required.

Principally, the Engineer shall carry out the day-to day qualitative and quantitative supervision of works' execution and construction contract administration on behalf of the Employer and the Municipality following the procedures and codes usually complied with for works executed by or on behalf of the Government of Nepal.

The powers vested in the Engineer thereto under the terms and conditions of this Contract are subject to limitations as stipulated in the above said "Conditions of Contract" in respect of taking major steps in construction contract administration notably referring to

- Approving assignment or sub-contracting
- Ordering suspension of work
- Issuing variation orders
- Certifying additional costs and payments
- Determining extensions of time
- Issuing a certificate of substantial completion
- Issuing a defects correction certificate



For which the Consultant shall firstly request the specific approval of the Municipality and subsequently also of the Employer in writing.

Whilst therefore being fully accountable to the Employer in ensuring that the works are executed within the tender total or such other sum as may become payable to the contractor under the provisions of his contract and within the scheduled time for completion, the Engineer also has duties towards the Municipality and the contractor in administrating and interpreting the contract properly and fairly to maintain the work schedule and to avoid disputes. Thereto, the Engineer shall ensure that the Municipality's and the contractor's rights under the construction contract are upheld by ensuring good verbal and written communication between himself, the Municipality and its representatives and the contractor and his representatives. The Engineer shall follow the contractor's progress carefully and forecast well ahead the needs for critical actions to be taken. He shall ensure, that items with a lead time or otherwise not readily available e.g. pipes, pumps and electrical installation items, are ordered well in time by the contractor. He shall also ensure that excessive quantities of materials are not ordered where the delivery of such quantities could cause difficulties on site or the materials could deteriorate.

In particular, the Engineer shall ensure that payments to the contractor can be made on time by giving ample notice and opportunity to the Municipality's representatives to carry out whatever quality checks and measurements they may wish prior to authorizing payment of amounts certified by the Engineer. The Engineer shall therefore agree with the Municipality's representatives on a regular basis and well in advance on items on which the Municipality's representatives wish to carry out checks and measurements and on the extent of such checks and measurements. Provided that the Municipality's representatives have been given adequate notice in writing to carry out own checks and measurements but fail to do so, works' execution will continue without delay and payment of the amounts certified by the Engineer will be deemed to be authorized. In such events, the Engineer shall state in writing to the Municipality with a copy to the Employer that the Municipality's representatives were requested to carry out own checks and measurements but failed to do so. This Clause is not in any way limiting the Employer's and Municipality's rights to carry out spot checks and measurements at any time.

The Engineer, during the Contract, shall provide the Employer with monthly reports indicating physical progress compared to the work schedule and cost aspects including amounts certified so far and during that month, and any financial implication; in the reports, the Engineer shall also include observations and comments on testing results and quality of workmanship.

7 SCOPE OF SERVICES, TASKS AND EXPECTED DELIVERABLES (not limited to)

The CONSULTANT shall perform or render professional services which consist generally of the following phases:

- Contract management and supervision of construction site
- Post-construction work



The Construction Phase (Contract management and Supervision work) shall include the following:

1. Coordinate full time Project Manager/ Engineer from municipality to oversee all the construction and renovation activities;
2. Develop a system of efficient cost control and monitoring of expected cost;
3. Work closely with the Client, to assist their representatives to carry out their obligations under the construction contract in order that the contractor is not hampered in any way in carrying out his duties
4. Keep accurate records of all site activities and operations and those required elsewhere for efficient works' execution by the contractor and others under the construction contract, including but not restricted to
 - Correspondence between Employer, Municipality, Consultant and contractor as well as other parties if necessary.
 - Minutes of scheduled meetings
 - Daily, weekly and monthly reports from the Engineer's Representative and the other staff appointed by the Engineer to assist the Engineer's Representative
 - Instructions, variation orders, approval forms, etc
 - level and survey books, including checks on setting-out and completed work
 - Work records, such as measurement books, level and dimension books and material delivery notes
 - Progress charts and drawings, including photographs
 - Test data and laboratory reports
 - Plant and labour returns
 - Financial records, including interim statements plus supporting particulars and certificates
 - Administrative records concerning leave, sickness, accidents, etc.
 - weather records
5. Prepare simple schematic monthly progress reports highlighting actual and potential problems, need for urgent decisions, and likely deviations from overall timing and costing plans;
6. Make recommendations to the client and employer (TDF) on *all claims of the contractor* relating to the execution and progress of the work, such as progress payments, variation orders, contract time extensions and suspensions, including interpretation of the Contract between the Client and the contractor;
7. Inspect and examine the actual construction of the project with such frequency and duration as may be necessary to fully instruct the contractors representatives on the work, the merits of the material and workmanship, and seeing to it that the work is done, in every particular aspect, strictly in accordance with the plans and specifications. On the basis of the consultant's observations, the consultant shall keep the client informed of defects and deficiencies in the work of contractors and shall condemn work found failing to conform with the Contract Documents, Annexes or Special Provisions of the Construction Contract, if any, and decisions of the client as conveyed;
8. Certify work accomplished and the contractor's monthly payment application with reference to the updated final cost estimate;
9. Determine, together with the authorized representative of the client, the issuance of corresponding Certificate for Payments based on their observations and the contractors'



Application for Payment, for the consideration of the client. These certificates will constitute a certification to the client and employer, which the work has progressed to the stage indicated and that to their best knowledge and inspection, the quality of the work performed by the contractor is in accordance with the construction contract documents. The consultant, the client's and the employer representative shall conduct the necessary inspection to determine the date of substantial and final completion of construction and thereby issue the *final certificate of payment* to the contractors;

10. Prepare large-scale shop drawings for constructions as required, and other additional plans and specifications as may be deemed necessary by the client for the proper execution of the work;
11. Interpret for both the client and contractor the contents and intents of the Construction Contract Documents, such as the working drawings, specifications and general conditions;
12. Assist in the technical and legal handing over process, guarantee and maintenance control, final payment and preparation of the project completion report;
13. Assist the clients working out technical details, the quantification of materials, and the preparations of cost estimated for each project, taking into account the provincial cost variations determined by the varying ecological and environmental conditions;

The post construction Phase shall include the following:

1. Provide periodical supervision and report to the client upon completion of the project; a report accompanied by a set of "as-built" plans indication any change and the reason for it, its authorization and effect on the final costs and utilization;
2. Collate and submit to the employer three (3) sets of "as-built" drawings including architectural, structural, electrical, sanitary, service-connected equipment and fixed furnishings and site planning work, all necessary for record purposes, building maintenance and repairs;
3. Advise the client and the contractor of any and all finishing touches on construction or installation activities necessary to render the building operational or ready for occupancy; and
4. Certify the completing of the project according to plans, Specifications and scope of work and recommends acceptance to the client.

8 General Provision

8.1 Commencement Date

Consultant will commence the supervision work of the project after completion of procurement work (Bidding process) by Client but in case the construction work has already commenced, consultant mobilization date will be the commence date. For each of the phases of work for which the Consultant is to render services, the commencement dates will be subject of specific consultation. The Consultant shall not commence until after receiving notice to proceed from the Employer. In the particular case of defects correction supervision, the services shall consist of intermittent site inspections either following a pre-determined schedule or upon call by the Employer or as otherwise agreed.

8.2 Personnel and Presence on Site

For the purposes of supervision and contract management, the Consultant shall be known as the Engineer Representative. The Consultant shall ensure that at all times during the project construction engineer shall

take charge of the operations on the site. The Engineer's Representative shall be authorized for managing site supervision and carrying out all contractual and administrative activities required under the Terms of Reference. The presence on site of the Engineer's Representative and other staff of the Consultant shall be recorded in timesheets in a format given in Appendix C, which shall be certified by the Project Manager/Engineer designated by the Municipality.

Further, in his head office, the Consultant shall appoint an officer-in-charge to act as his authorized representative in all matters related to this Agreement.

8.3 Site Office

The Consultant themselves have to make appropriate arrangements for a site office, on or in the vicinity of the site, for the duration of the contract management and supervision of construction services. The office shall provide for safe storage of documents, drawings, instruments, samples, etc.

8.4 Requirements

Experience of Consulting Firms:

- Experience on supervision and contract Management of Building Projects.
- Experience on design, estimate, and layout of building projects.

Note: Experience on such in public sector is preferable.

Mandatory Requirements for the Evaluation of the Experience of the Consulting Firm:

- Only the work completed during last **7 (seven) years** will be considered while evaluating the firm experiences and consultant fee less than 5 lakh shall not be considered
- Technical Proposal shall be evaluated on the basis of information duly provided by the Consultant. Information must be supported by relevant evidences such as Certificates, official letters, bills, vouchers and necessary commitments wherever applicable but work agreement papers are not necessary
- The document (i.e. proposal) submitted by the consultant must duly sign the whole submitted document.

Proposed Personnel Requirements

The professional personnel resources required for this assignment shall cover the following positions with estimated inputs

The cost required for such staff should be covered in the rates of item works included in the Financial Proposal. Similarly, the Consultant is required to manage all the equipment, vehicles, logistic and other facilities required for conducting assign work by itself. The cost of such provisions should be covered in the rates of the item works included in Financial Proposal.

Note: In case construction work does not finish as mention in contract agreement supervision consultant may have to mobilize site engineer as necessary.

Qualification of the Individuals

Structural Engineer

- a. S/he must have M.Sc. in Structure Engineering or equivalent qualification at least 5 years of experience with experience in similar project. {Should have experience of analysis and design of at least two projects};
- b. Ensure overall coordination between engineering representative of consultant and with;
- c. Should have knowledge on review of structural design and finalization of structural design and drawings including demolition drawings if necessary;
- d. Ensure the overall structural design is as per Nepal National Building Code and Other Standards;
- e. Assist team leader to complete the assignment;
- f. Work in close coordination with other professionals, as and when necessary.

Engineer Representative- Site Engineer

- a. He must have Bachelor Degree in civil engineering or equivalent qualification at least 5 years of experience with 3 years of relevant working experience after bachelor degree.
- b. Should have worked as site engineer for supervision of at least 2 similar projects of similar size.
- c. Specific experience on design/ review of DPR and contract management of any infrastructure project.

Mandatory Requirements for The Evaluation of the CVs of Personnel Proposed:

- a. The consultants are requested to submit the following documents such as academic qualification and experience of the experts proposed. Any missing data at the time of submission will lead to zero score for the CVs of the concerned expert:
- b. While submitting Curriculum vitae of the proposed team members, the final awarded degree required for the eligibility must be attached along with Curriculum Vitae. The CV of all the experts should be signed by them and should be supported by Nepal Engineering council and other council certificates, academic certificates and other certificates wherever necessary.
- c. If other experts designated for the proposed assignment does not meet the minimum criteria, consultant's proposal shall still be considered valid and shall duly be evaluated. However the proposed staff's quality lacks the minimum criteria the expert shall be awarded zero score. Still if the firm wins the contract, the expert should be replaced with qualified expert.

8.5 Government Indemnity

The consultant shall be responsible for any damage to life, property that may arise out of their works and they shall take all necessary insurance provision to indemnify any claims for compensation that may arise through their negligence.



8.6 Mode of Billing and Payments

1. The payment of the consultant's fee shall be made as follows:
 - I. Monthly Payment will be made as accordance to Attendance sheet approved by client.
 - II. Other payment regarding report will be made after submission of report and related documents
2. Payments will be normally made within 30 days of receipt of the consultant invoices, subject to the submission and approval of the reports required to be made with respect to the invoiced services.
3. No final payment shall be made until the consultant submits to the employer a certification to the effect that the undertaking provided herein has been satisfactorily completed. In case of default of the contractor, at any stage of construction, payment to the consultant shall be proportional to the construction work thus accomplished.

8.7 Use of Formats

For the exchange of notices between the Employer, the Consultant, the client and the contractor, the Consultant shall to the extent feasible develop formats as far as such interactions are not already covered by the formats given in the Appendix to these Terms of Reference. The particular attention of the Consultant is drawn to the formats to be used in the case a variation is necessary under the construction contract. Firstly, the Consultant shall issue a **Notice of Pending Variation of Work**, certified by the Municipality, to the Contractor. Upon receipt of the Contractor's response, the Consultant shall prepare the **Variation Account** and obtain certification from the Project Officer designated by the Municipality and subsequently of the Employer. Only then, the Consultant shall issue a **Variation Order** to the Contractor.

8.8 Reporting

The Consultant shall maintain Daily Site Diaries as per format included in Appendix B to these Terms of Reference. The daily site diaries shall be kept at the Consultant's site office for inspection by the Employer at any time during the services. Upon completion of the services, the diaries shall be handed over to the Employer. Consultant shall produce minutes of meeting conducted with client, employer, contractor and other related stakeholder as on when required.

Besides, the Consultant shall submit reports as per schedule included in the Agreement. All reporting shall be in English. For the monthly progress reports regarding the contract management and supervision of construction services, the Consultant shall follow the table of contents as included in Appendix A to these Terms of Reference. All reports shall be prepared in 2 copies, of which 2 are to be sent to the Employer and 1 to the Client.

8.9 Deferred Services

In case the execution of the works is delayed or suspended due to the occurrence of an excepted risk or any other reason and the Employer is of the opinion that the Consultant's presence on the site is not required for at least one month, then the Employer may request the Consultant to interrupt his services and the Consultant shall forthwith withdraw his personnel from the site. Upon first instruction from the Employer to do so, the Consultant shall re-assign his personnel to the site and continue to render the services.



For the period of the interruption, no payment will be made. An interruption of the services will not entitle the Consultant to a change of his man-month rates.

8.10 Extra Services

Unless otherwise negotiated, the periods for the services entered in the Agreement shall not be exceeded by the Consultant. In particular, the Consultant shall not continue to provide contract management and supervision of construction or defects correction supervision services beyond the stipulated times, except when requested in writing by the Employer.

If, in the opinion of the Employer, it is necessary to carry out any work beyond the Terms of Reference for the purposes of the project, such additional work shall be carried out under a supplementary agreement between the Employer and the Consultant. The remuneration for such additional services shall be calculated on the basis of the rates applicable to this Agreement.

8.11 De- Mobilization

The employer may de-mobilize the consultant representative if the employer foresees there will be no satisfactory work at construction site for more than two weeks.

Or in case the consultant representative involves in any unusual behaviour /do not work properly or find inappropriate to complete the task at site, in such case the consultant shall arrange another site in changer as a replacement of him/her within short period of notice.

I. Form of Contract

II. General Conditions of Contract

A. GENERAL PROVISIONS

1. Definitions

1.1. Unless the context otherwise requires, the following terms whenever used in this Contract have the following meanings:

- (a) "Applicable Guidelines" means the policies of the Development Partner (DP) governing the selection and Contract award process, in case of DP funded project.
- (b) "Applicable Law" means the laws and any other instruments having the force of law in Nepal as they may be issued and in force from time to time.
- (c) "Borrower [or Recipient or Beneficiary]" means the Government, Government agency or other entity that signs the financing [or loan/grant/project] agreement with the Development Partner.
- (d) "Client" means [procuring entity/the implementing/ executing] agency that signs the Contract for the Services with the Selected Consultant.
- (e) "Consultant" means a legally-established professional consulting firm or entity selected by the Client to provide the Services under the signed Contract.
- (f) "Contract" means the legally binding written agreement signed between the Client and the Consultant and which includes all the attached documents listed in its paragraph 1 of the Form of Contract (the General Conditions (GCC), the Special Conditions (SCC), and the Appendices).
- (g) "Day" means a working day unless indicated otherwise.
- (h) "Development Partner (DP)" means the country/institution funding the project **as specified in the SCC**.
- (i) "Effective Date" means the date on which this Contract comes into force and effect pursuant to Clause GCC 11.
- (j) "Experts" means, collectively, Key Experts, Non-Key Experts or any other personnel of the Consultant, Sub-consultant or JV member(s) assigned by the Consultant to perform the Services or any part thereof under the Contract.
- (k) "Foreign Currency" means any currency other than the currency of the Client's country.
- (l) "GCC" means these General Conditions of Contract.

- (m) "Government" means the government of Nepal (GoN).
- (n) "Joint Venture (JV)" means an association with or without a legal personality distinct from that of its members, of more than one entity where one member has the authority to conduct all businesses for and on behalf of any and all the members of the JV, and where the members of the JV are jointly and severally liable to the Client for the performance of the Contract.
- (o) "Key Expert(s)" means an individual professional whose skills, qualifications, knowledge and experience are critical to the performance of the Services under the Contract and whose Curricula Vitae (CV) was taken into account in the technical evaluation of the Consultant's proposal.
- (p) "Local Currency" means the currency of Nepal (NPR).
- (q) "Non-Key Expert(s)" means an individual professional provided by the Consultant or its Sub-consultant to perform the Services or any part thereof under the Contract.
- (r) "Party" means the Client or the Consultant, as the case may be, and "Parties" means both of them.
- (s) "SCC" means the Special Conditions of Contract by which the GCC may be amended or supplemented but not over-written.
- (t) "Services" means the work to be performed by the Consultant pursuant to this Contract, as described in Appendix A hereto.
- (u) "Sub-consultants" means an entity to whom/which the Consultant subcontracts any part of the Services while remaining solely liable for the execution of the Contract.
- (v) "Third Party" means any person or entity other than the Government, the Client, the Consultant or a Sub-consultant.

2. Relationship between the Parties

2.1. Nothing contained herein shall be construed as establishing a relationship of master and servant or of principal and agent as between the Client and the Consultant. The Consultant, subject to this Contract, has complete charge of the Experts and Sub-consultants, if any, performing the Services and shall be fully responsible for the Services performed by them or on their behalf hereunder.

3. Law Governing Contract

3.1. This Contract, its meaning and interpretation, and the relation between the Parties shall be governed by the Applicable Law of Nepal.

4. Language

4.1. This Contract has been executed in the English language, which shall be the binding and controlling language for all matters relating to the meaning or interpretation of this Contract.



- 5. Headings** 5.1. The headings shall not limit, alter or affect the meaning of this Contract.
- 6. Communications** 6.1. Any communication required or permitted to be given or made pursuant to this Contract shall be in writing in the language specified in Clause GCC 4. Any such notice, request or consent shall be deemed to have been given or made when delivered in person to an authorized representative of the Party to whom the communication is addressed, or when sent to such Party at the address specified in the **SCC**.
- 6.2. A Party may change its address for notice hereunder by giving the other Party any communication of such change to the address specified in the **SCC**.
- 7. Location** 7.1. The Services shall be performed at such locations as are specified in **Appendix A** hereto and, where the location of a particular task is not so specified, at such locations, whether in the Government's country or elsewhere, as the Client may approve.
- 8. Authority of Member in Charge** 8.1. In case the Consultant is a Joint Venture, the members hereby authorize the member specified in the **SCC** to act on their behalf in exercising all the Consultant's rights and obligations towards the Client under this Contract, including without limitation the receiving of instructions and payments from the Client.
- 9. Authorized Representatives** 9.1. Any action required or permitted to be taken, and any document required or permitted to be executed under this Contract by the Client or the Consultant may be taken or executed by the officials specified in the **SCC**.
- 10. Corrupt and Fraudulent Practices** 10.1 The GoN/DP requires compliance with its policy in regard to corrupt and fraudulent/prohibited practices as set forth in **Attachment 1** to the GCC.
- a. Commissions and Fees** 10.2 The Client requires the Consultant to disclose any commissions, gratuities or fees that may have been paid or are to be paid to agents or any other party with respect to the selection process or execution of the Contract. The information disclosed must include at least the name and address of the agent or the other party, the amount and currency, and the purpose of the commission, gratuity or fee. Failure to disclose such commissions and gratuities may result in termination of the Contract.

B. COMMENCEMENT, COMPLETION, MODIFICATION AND TERMINATION OF CONTRACT

- 11. Effectiveness of Contract** 11.1. This Contract shall come into force and effect on the date (the "Effective Date") of the Client's notice to the Consultant instructing the Consultant to begin carrying out the Services. This notice shall confirm that the effectiveness conditions, if any, listed in




the **SCC** have been met.

12. Termination of Contract for Failure to Become Effective

12.1. If this Contract has not become effective within such time period after the date of Contract signature as specified in the **SCC**, either Party may, by not less than thirty (30) days written notice to the other Party, declare this Contract to be null and void, and in the event of such a declaration by either Party, neither Party shall have any claim against the other Party with respect hereto.

13. Commencement of Services

13.1. The Consultant shall confirm availability of Key Experts and begin carrying out the Services not later than the number of days after the Effective Date specified in the **SCC**.

14. Expiration of Contract

14.1. Unless terminated earlier pursuant to Clause GCC 19 hereof, this Contract shall expire at the end of such time period after the Effective Date as **specified in the SCC** or such other time period as the Parties may agree in writing.

15. Entire Agreement

15.1. This Contract contains all covenants, stipulations and provisions agreed by the Parties. No agent or representative of either Party has authority to make, and the Parties shall not be bound by or be liable for, any statement, representation, promise or agreement not set forth herein.

16. Modifications or Variations

16.1. Any modification or variation of the terms and conditions of this Contract, including any modification or variation of the scope of the Services, may only be made by written agreement between the Parties. However, each Party shall give due consideration to any proposals for modification or variation made by the other Party.

17. Force Majeure

a. Definition

17.1. For the purposes of this Contract, "Force Majeure" means an event which is beyond the reasonable control of a Party, is not foreseeable, is unavoidable, and makes a Party's performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible under the circumstances, and subject to those requirements, includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other adverse weather conditions, strikes, lockouts or other industrial action, confiscation or any other action by Government agencies.

17.2. Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or such Party's Experts, Sub-consultants or agents or employees, nor (ii) any event which a diligent Party could reasonably have been expected to both take into account at the time of the conclusion of this Contract, and avoid or overcome in the carrying out of its obligations hereunder.

17.3. Force Majeure shall not include insufficiency of funds or failure to make any payment required hereunder.

b. **No Breach of Contract** 17.4. The failure of a Party to fulfill any of its obligations hereunder shall not be considered to be a breach of, or default under, this Contract insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms and conditions of this Contract.

c. **Measures to be Taken** 17.5. A Party affected by an event of Force Majeure shall take all reasonable measures to remove such Party's inability to fulfill its obligations hereunder with a minimum of delay.

17.6. A Party affected by an event of Force Majeure shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall take all reasonable measures to minimize the consequences of any event of Force Majeure.

17.7. A Party affected by an event of Force Majeure shall notify the other Party of such event as soon as possible, and in any case not later than fifteen (15) calendar days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give written notice of the restoration of normal conditions as soon as possible.

d. **Extension of Time (EoT)** 17.8. Any period within which a Party shall, pursuant to this Contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

17.9. During the period of their inability to perform the Services as a result of an event of Force Majeure, the Consultant, upon instructions by the Client, shall either:

- (a) demobilize, in which case the Consultant shall be reimbursed for additional costs they reasonably and necessarily incurred, and, if required by the Client, in reactivating the Services; or
- (b) continue with the Services to the extent reasonably possible, in which case the Consultant shall continue to be paid under the terms of this Contract and be reimbursed for additional costs reasonably and necessarily incurred.

17.10. The Consultant shall submit an application to the Client for extension of time, stating the causes for delay with supporting evidence within 7 days before the expiry of the Contract completion date. The approval of EoT shall be subject to verification by the Client whether:

- (a) the consultant had made the best possible efforts to complete the work in due time ,



- (b) the facilities to be provided by the Client as per the contract to the Consultant was made in time or not,
- (c) the delay was as a result of Force Majeure or not.

18. Suspension

18.1. The Client may, by written notice of suspension to the Consultant, suspend all payments to the Consultant hereunder if the Consultant fails to perform any of its obligations under this Contract, including the carrying out of the Services, provided that such notice of suspension (i) shall specify the nature of the failure, and (ii) shall request the Consultant to remedy such failure within a period not exceeding thirty (30) calendar days after receipt by the Consultant of such notice of suspension.

19. Termination

19.1 This Contract may be terminated by either Party as per provisions set up below:

a. By the Client

19.1.1 The Client may terminate this Contract in case of the occurrence of any of the events specified in paragraphs (a) through (e) of this Clause. In such an occurrence the Client shall give at least thirty (30) calendar days' written notice of termination to the Consultant in case of the events referred to in (a) through (d); and at least sixty (60) calendar days' written notice in case of the event referred to in (e):

- (a) If the Consultant fails to remedy a failure in the performance of its obligations hereunder, as specified in a notice of suspension pursuant to Clause GCC 18 hereinabove, within thirty (30) days of receipt of such notice of suspension or within such further period as the Client may have subsequently approved in writing;
- (b) If the Consultant becomes (or, if the Consultant consists of more than one entity, if any of its members becomes) insolvent or bankrupt or enter into any agreements with their creditors for relief of debt or take advantage of any law for the benefit of debtors or go into liquidation or receivership whether compulsory or voluntary;
- (c) If the Consultant fails to comply with any final decision reached as a result of arbitration proceedings pursuant to Clause GCC 48.1;
- (d) If, as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than sixty (60) calendar days;
- (e) If the Client, in its sole discretion and for any reason whatsoever, decides to terminate this Contract;
- (f) If the Consultant fails to furnish the professional liability insurance within 30 days from the date of signing of the contract agreement.



19.1.2 Furthermore, if the Client determines that the Consultant has engaged in corrupt, fraudulent, collusive, coercive [or obstructive] practices, in competing for or in executing the Contract, then the Client may, after giving fifteen (15) calendar days written notice to the Consultant, terminate the Consultant's employment under the Contract.

b. By the Consultant

19.1.3 The Consultant may terminate this Contract, by not less than thirty (30) calendar days' written notice to the Client, in case of the occurrence of any of the events specified in paragraphs (a) through (d) of this Clause.

- (a) If the Client fails to pay any money due to the Consultant pursuant to this Contract and not subject to dispute pursuant to Clauses GCC 48.1 within forty-five (45) calendar days after receiving written notice from the Consultant that such payment is overdue.
- (b) If, as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than sixty (60) calendar days.
- (c) If the Client fails to comply with any final decision reached as a result of arbitration pursuant to Clause GCC 48.1.
- (d) If the Client is in material breach of its obligations pursuant to this Contract and has not remedied the same within forty-five (45) days (or such longer period as the Consultant may have subsequently approved in writing) following the receipt by the Client of the Consultant's notice specifying such breach.

c. Cessation of Rights and Obligations

19.1.4 Upon termination of this Contract pursuant to Clauses GCC 12 or GCC 19 hereof, or upon expiration of this Contract pursuant to Clause GCC 14, all rights and obligations of the Parties hereunder shall cease, except (i) such rights and obligations as may have accrued on the date of termination or expiration, (ii) the obligation of confidentiality set forth in Clause GCC 23, (iii) the Consultant's obligation to permit inspection, copying and auditing of their accounts and records set forth in Clause GCC 26, and (iv) any right which a Party may have under the Applicable Law.

d. Cessation of Services

19.1.5 Upon termination of this Contract by notice of either Party to the other pursuant to Clauses GCC 19a or GCC 19b, the Consultant shall, immediately upon dispatch or receipt of such notice, take all necessary steps to bring the Services to a close in a prompt and orderly manner and shall make every reasonable effort to keep expenditures for this purpose to a minimum. With respect to documents prepared by the Consultant and equipment and materials furnished by the Client, the Consultant shall proceed as provided, respectively,



by Clauses GCC 28 or GCC 29.

e. Payment upon Termination

19.1.6 Upon termination of this Contract, the Client shall make the following payments to the Consultant:

- (a) payment for Services satisfactorily performed prior to the effective date of termination; and
- (b) in the case of termination pursuant to paragraphs (d) and (e) of Clause GCC 19.1.1, reimbursement of any reasonable cost incidental to the prompt and orderly termination of this Contract, including the cost of the return travel of the Experts.

C. OBLIGATIONS OF THE CONSULTANT

20. General

a. Standard of Performance

20.1 The Consultant shall perform the Services and carry out the Services with all due diligence, efficiency and economy, in accordance with generally accepted professional standards and practices, and shall observe sound management practices, and employ appropriate technology and safe and effective equipment, machinery, materials and methods. The Consultant shall always act, in respect of any matter relating to this Contract or to the Services, as a faithful adviser to the Client, and shall at all times support and safeguard the Client's legitimate interests in any dealings with the third parties.

20.2 The Consultant shall employ and provide such qualified and experienced Experts and Sub-consultants as are required to carry out the Services.

20.3 The Consultant may subcontract part of the Services to an extent and with such Key Experts and Sub-consultants as may be approved in advance by the Client. Notwithstanding such approval, the Consultant shall retain full responsibility for the Services.

b. Law Applicable to Services

20.4 The Consultant shall perform the Services in accordance with the Contract and the Applicable Law and shall take all practicable steps to ensure that any of its Experts and Sub-consultants, comply with the Applicable Law.

20.5 Throughout the execution of the Contract, the Consultant shall comply with the import of goods and services prohibitions in the Client's country when

- (a) as a matter of law or official regulations, Client's country prohibits commercial relations with that country; or
- (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the



Charter of the United Nations, the Client's Country prohibits any import of goods from that country or any payments to any country, person, or entity in that country.

20.6 The Client shall notify the Consultant in writing of relevant local customs, and the Consultant shall, after such notification, respect such customs.

21. Conflict of Interests

21.1 The Consultant shall hold the Client's interests paramount, without any consideration for future work, and strictly avoid conflict with other assignments or their own corporate interests.

a. Consultant Not to Benefit from Commissions, Discounts, etc.

21.1.1 The payment of the Consultant pursuant to GCC F (Clauses GCC 39 through 45) shall constitute the Consultant's only payment in connection with this Contract and, subject to Clause GCC 21.1.3, the Consultant shall not accept for its own benefit any trade commission, discount or similar payment in connection with activities pursuant to this Contract or in the discharge of its obligations hereunder, and the Consultant shall use its best efforts to ensure that any Sub-consultants, as well as the Experts and agents of either of them, similarly shall not receive any such additional payment.

21.1.2 Furthermore, if the Consultant, as part of the Services, has the responsibility of advising the Client on the procurement of goods, works or services, the Consultant shall comply with any applicable procurement guidelines as per the prevailing Public Procurement Act and Regulations of the GoN (or of the Donors/funding agencies) and shall at all times exercise such responsibility in the best interest of the Client. Any discounts or commissions obtained by the Consultant in the exercise of such procurement responsibility shall be for the account of the Client.

b. Consultant and Affiliates Not to Engage in Certain Activities

21.1.3 The Consultant agrees that, during the term of this Contract and after its termination, the Consultant and any entity affiliated with the Consultant, as well as any Sub-consultants and any entity affiliated with such Sub-consultants, shall be disqualified from providing goods, works or services (other than the Services and any continuation thereof) for any project resulting from or closely related to the Services.

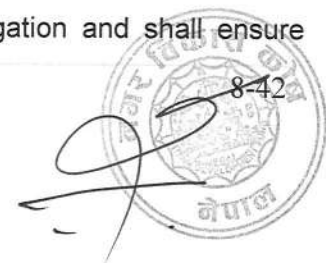
c. Prohibition of Conflicting Activities

21.1.4 The Consultant shall not engage, and shall cause their Personnel as well as its Sub-consultants and their Personnel not to engage, either directly or indirectly, in any of the following activities:

- a. during the term of this Contract, any business or professional activities in Nepal which would conflict with the activities assigned to them under this Contract; and
- b. after the termination of this Contract, such other activities as may be specified in the SCC

d. Strict Duty to

21.1.5 The Consultant has an obligation and shall ensure



- Disclose
Conflicting
Activities** that its Personnel and Sub-consultants shall have an obligation to disclose any situation of actual or potential conflict that impacts their capacity to serve the best interest of their Client, or that may reasonably be perceived as having this effect. Failure to disclose said situations may lead to the termination of its Contract.
- 22. Conduct of
Consultants**
- 22.1 The Consultant shall be responsible to fulfill his obligations as per the requirement of the Contract Agreement, RFP documents and GoN's Procurement Act and Regulations.
- 22.2 The consultant shall not carry out or cause to carry out the following acts with an intention to influence the implementation of the procurement process or the contract agreement :
- (i) give or propose improper inducement directly or indirectly,
 - (ii) distortion or misrepresentation of facts
 - (iii) engaging or being involved in corrupt or fraudulent practice
 - (iv) Interference in participation of other prospective consultants.
 - (v) coercion or threatening directly or indirectly to impair or harm, any party or the property of the party involved in the procurement proceedings,
 - (vi) collusive practice among consultants before or after submission of proposals for distribution of works among consultants or fixing artificial/uncompetitive proposal price with an intention to deprive the Client the benefit of open competitive proposal price.
 - (vii) contacting the Client with an intention to influence the Client with regards to the proposals or interference of any kind in examination and evaluation of the proposals during the period after opening of proposals up to then notification of award of contract
- 23. Confidentiality**
- 23.1 The Consultants, their Sub-consultants, and the Personnel of either of them shall not, either during the term or within two (2) years after the expiration of this Contract, disclose any proprietary or confidential information relating to the Project, the Services, this Contract, or the Client's business or operations without the prior written consent of the Client.
- 24. Liability of the
Consultant**
- 24.1 Subject to additional provisions, if any, set forth in the SCC, the Consultant's liability under this Contract shall be as determined under the Applicable Law.
- 25. Insurance to be
Taken out by the**
- 25.1 The Consultant (i) shall take out and maintain, and shall cause any Sub-consultants to take out and maintain, at its (or the Sub-consultants', as the case may be) own cost but on



- Consultant** terms and conditions approved by the Client, insurance against the risks, and for the coverage specified in the **SCC**, and (ii) at the Client's request, shall provide evidence to the Client showing that such insurance has been taken out and maintained and that the current premiums therefore have been paid. The Consultant shall ensure that such insurance is in place prior to commencing the Services as stated in Clause GCC 13.
- 25.2 The Consultant shall take out and maintain professional liability insurance within 30 days of signing of the contract agreement.
- 26. Accounting, Inspection and Auditing**
- 26.1 The Consultant shall keep, and shall make all reasonable efforts to cause its Sub-consultants to keep, accurate and systematic accounts and records in respect of the Services and in such form and detail as will clearly identify relevant time changes and costs.
- 26.2. The Consultant shall permit and shall cause its Sub-consultants to permit, the Client/DP and/or persons appointed by the Client/DP to inspect the Site and/or all accounts and records relating to the performance of the Contract and the submission of the Proposal to provide the Services, and to have such accounts and records audited by auditors appointed by the Client/DP if requested by the Client/DP. The Consultant's attention is drawn to Clause GCC 10 which provides, inter alia, that acts intended to materially impede the exercise of the Client/DP's inspection and audit rights provided for under this Clause GCC26.2 constitute a prohibited practice subject to contract termination.
- 27. Reporting Obligations**
- 27.1 The Consultant shall submit to the Client the reports and documents specified in **Appendix A**, in the form, in the numbers and within the time periods set forth in the said Appendix.
- 28. Proprietary Rights of the Client in Reports and Records**
- 28.1 Unless otherwise indicated in the **SCC**, all reports and relevant data and information such as maps, diagrams, plans, databases, other documents and software, supporting records or material compiled or prepared by the Consultant for the Client in the course of the Services shall be confidential and become and remain the absolute property of the Client. The Consultant shall, not later than upon termination or expiration of this Contract, deliver all such documents to the Client, together with a detailed inventory thereof. The Consultant may retain a copy of such documents, data and/or software but shall not use the same for purposes unrelated to this Contract without prior written approval of the Client.
- 28.2 If license agreements are necessary or appropriate between the Consultant and third parties for purposes of development of the plans, drawings, specifications, designs, databases, other documents and software, the Consultant shall obtain the Client's prior written approval to such agreements, and the Client shall be entitled at its



discretion to require recovering the expenses related to the development of the program(s) concerned. Other restrictions about the future use of these documents and software, if any, shall be specified in the **SCC**.

29. Equipment, Vehicles and Materials

29.1 Equipment, vehicles and materials made available to the Consultant by the Client, or purchased by the Consultant wholly or partly with funds provided by the Client, shall be the property of the Client and shall be marked accordingly. Upon termination or expiration of this Contract, the Consultant shall make available to the Client an inventory of such equipment, vehicles and materials and shall dispose of such equipment, vehicles and materials in accordance with the Client's instructions. While in possession of such equipment, vehicles and materials, the Consultant, unless otherwise instructed by the Client in writing, shall insure them at the expense of the Client in an amount equal to their full replacement value.

29.2 Any equipment or materials brought by the Consultant or its Experts into the Client's country for the use either for the project or personal use shall remain the property of the Consultant or the Experts concerned, as applicable.

D. CONSULTANT'S EXPERTS AND SUB-CONSULTANTS

30. Description of Key Experts

30.1 The title, agreed job description, minimum qualification and time-input estimates to carry out the Services of each of the Consultant's Key Experts are described in **Appendix B**.

31. Replacement of Key Experts

31.1 Except as the Client may otherwise agree in writing, no changes shall be made in the Key Experts.

31.2 Notwithstanding the above, the substitution of Key Experts during Contract execution may be considered only based on the Consultant's written request and due to circumstances outside the reasonable control of the Consultant, including but not limited to death or medical incapacity. In such case, the Consultant shall forthwith provide as a replacement, a person of equivalent or better qualifications and experience, and at the same rate of remuneration.

32. Removal of Experts or Sub-consultants

32.1 If the Client finds that any of the Experts or Sub-consultant has committed serious misconduct or has been charged with having committed a criminal action, or shall the Client determine that Consultant's Expert or Sub-consultant have engaged in corrupt, fraudulent, collusive, coercive *[or obstructive]* practice while performing the Services, the Consultant shall, at the Client's written request, provide a replacement.

32.2 In the event that any of Key Experts or Sub-consultants is found by the Client to be incompetent or incapable in discharging assigned duties, the Client, specifying the grounds therefore, may



request the Consultant to provide a replacement.

32.3 Any replacement of the removed Experts or Sub-consultants shall possess better qualifications and experience and shall be acceptable to the Client.

32.4 The Consultant shall bear all costs arising out of or incidental to any removal and/or replacement of such Experts.

E. OBLIGATIONS OF THE CLIENT

33. Assistance and Exemptions

33.1 Unless otherwise specified in the **SCC**, the Client shall use its best efforts to:

- (a) Assist the Consultant with obtaining work permits and such other documents as shall be necessary to enable the Consultant to perform the Services.
- (b) Assist the Consultant with promptly obtaining, for the Experts and, if appropriate, their eligible dependents, all necessary entry and exit visas, residence permits, exchange permits and any other documents required for their stay in the Client's country while carrying out the Services under the Contract.
- (c) Facilitate prompt clearance through customs of any property required for the Services and of the personal effects of the Experts and their eligible dependents.
- (d) Issue to officials, agents and representatives of the Government all such instructions and information as may be necessary or appropriate for the prompt and effective implementation of the Services.
- (e) Assist the Consultant and the Experts and any Sub-consultants employed by the Consultant for the Services with obtaining exemption from any requirement to register or obtain any permit to practice their profession or to establish themselves either individually or as a corporate entity in the Client's country according to the applicable law in the Client's country.
- (f) Assist the Consultant, any Sub-consultants and the Experts of either of them with obtaining the privilege, pursuant to the applicable law in the Client's country, of bringing into the Client's country reasonable amounts of foreign currency for the purposes of the Services or for the personal use of the Experts and of withdrawing any such amounts as may be earned therein by the Experts in the execution of the Services.
- (g) Provide to the Consultant any such other assistance as may be specified in the **SCC**.

34. Access to Project

34.1 The Client warrants that the Consultant shall have, free of




- Site** charge, unimpeded access to the project site in respect of which access is required for the performance of the Services. The Client will be responsible for any damage to the project site or any property thereon resulting from such access and will indemnify the Consultant and each of the experts in respect of liability for any such damage, unless such damage is caused by the willful default or negligence of the Consultant or any Sub-consultants or the Experts of either of them.
- 35. Change in the Applicable Law Related to Taxes and Duties** 35.1 If, after the date of this Contract, there is any change in the applicable law in the Client's country with respect to taxes and duties which increases or decreases the cost incurred by the Consultant in performing the Services, then the remuneration and reimbursable expenses otherwise payable to the Consultant under this Contract shall be increased or decreased accordingly by agreement between the Parties hereto, and corresponding adjustments shall be made to the ceiling amounts specified in Clause GCC 39.1.
- 36. Services, Facilities and Property of the Client** 36.1 The Client shall make available to the Consultant and the Experts, for the purposes of the Services and free of any charge, the services, facilities and property described in the Terms of Reference (**Appendix A**) at the times and in the manner specified in said **Appendix A**.
- 37. Counterpart Personnel** 37.1 The Client shall make available to the Consultant free of charge such professional and support counterpart personnel, to be nominated by the Client with the Consultant's advice, if specified in **Appendix A**.
- 37.2 If counterpart personnel are not provided by the Client to the Consultant as and when specified in **Appendix A**, the Client and the Consultant shall agree on (i) how the affected part of the Services shall be carried out, and (ii) the additional payments, if any, to be made by the Client to the Consultant as a result thereof pursuant to Clause GCC 39.2
- 37.3 Professional and support counterpart personnel, excluding Client's liaison personnel, shall work under the exclusive direction of the Consultant. If any member of the counterpart personnel fails to perform adequately any work assigned to such member by the Consultant that is consistent with the position occupied by such member, the Consultant may request the replacement of such member, and the Client shall not unreasonably refuse to act upon such request.
- 38. Payment Obligation** 38.1 In consideration of the Services performed by the Consultant under this Contract, the Client shall make such payments to the Consultant for the deliverables specified in **Appendix A** and in such manner as is provided by GCC F below.



F. PAYMENTS TO THE CONSULTANT

- 39. Contract Price**
- 39.1 The Contract price is fixed and is set forth in the **SCC**. The Contract price breakdown is provided in **Appendix C**.
- 39.2 Any change to the Contract price specified in Clause 39.1 can be made only if the Parties have agreed to the revised scope of Services pursuant to Clause GCC 16 and have amended in writing the Terms of Reference in **Appendix A**.
- 40. Taxes and Duties**
- 40.1 The Consultant, Sub-consultants and Experts are responsible for meeting any and all tax liabilities arising out of the Contract.
- 41. Currency of Payment**
- 41.1 Any payment under this Contract shall be made in the currency (ies) specified in the **SCC**.
- 42. Mode of Billing and Payment**
- 42.1 The total payments under this Contract shall not exceed the Contract price set forth in Clause GCC 39.1.
- 42.2 The payments under this Contract shall be made in lump-sum installments against deliverables specified in **Appendix A**. The payments will be made according to the payment schedule stated in the **SCC**.
- 42.2.1 Advance payment: Unless otherwise indicated in the **SCC**, an advance payment shall be made against an advance payment bank guarantee acceptable to the Client in an amount (or amounts) and in a currency (or currencies) specified in the **SCC**. Such guarantee (i) is to remain effective until the advance payment has been fully set off, and (ii) is to be in the form set forth in **Appendix D**, or in such other form as the Client shall have approved in writing. The advance payments will be set off by the Client in equal portions against the lump-sum installments specified in the **SCC** until said advance payments have been fully set off.
- 42.2.2 The Lump-Sum Installment Payments. The Client shall pay the Consultant within sixty (60) days after the receipt by the Client of the deliverable(s) and the cover invoice for the related lump-sum installment payment. The payment can be withheld if the Client does not approve the submitted deliverable(s) as satisfactory in which case the Client shall provide comments to the Consultant within the same sixty (60) days period. The Consultant shall thereupon promptly make any necessary corrections, and thereafter the foregoing process shall be repeated.
- 42.2.3 The Final Payment .The final payment under this Clause shall be made only after the final report I have been submitted by the Consultant and approved as satisfactory by the Client. The Services shall then be deemed completed and finally

accepted by the Client. The last lump-sum installment shall be deemed approved for payment by the Client within ninety (90) calendar days after receipt of the final report by the Client unless the Client, within such ninety (90) calendar day period, gives written notice to the Consultant specifying in detail deficiencies in the Services, the final report. The Consultant shall thereupon promptly make any necessary corrections, and thereafter the foregoing process shall be repeated.

42.2.4 All payments under this Contract shall be made to the accounts of the Consultant specified in the **SCC**.

42.2.5 With the exception of the final payment under 41.2.3 above, payments do not constitute acceptance of the whole Services nor relieve the Consultant of any obligations hereunder.

43. Retention

43.1. The Client shall retain from each payment due to the Consultant the proportion **stated in the SCC** until Completion of the whole of the Works.

43.2. One half the total amounts retained shall be repaid to the Consultant at the time of the payment of the Final Bill pursuant to GCC Clause 42.2.3 and the remaining half shall be paid to the consultant within 15 days after submission of document issued by the concerned Internal Revenue Office that the consultant has submitted his Income Returns.

44. Interest on Delayed Payments

44.1. If the Client had delayed payments beyond fifteen (15) days after the due date stated in Clause GCC 42.2.2, interest shall be paid to the Consultant on any amount due by, not paid on, such due date for each day of delay at the annual rate stated in the SCC.

45. Liquidated Damages

45.1. The Consultant shall pay liquidated damages to the Client at the rate per day stated in the SCC for each day that the completion of services is later than the Completion Date. The total amount of liquidated damages shall not exceed the amount defined in the SCC. Beyond this limit the contract may be terminated by the Client. The Client may deduct liquidated damages from any payments due to the Consultant. Payment of liquidated damages shall not affect the Consultant's liabilities.

G. FAIRNESS AND GOOD FAITH

46. Good Faith

46.1 The Parties undertake to act in good faith with respect to each other's rights under this Contract and to adopt all reasonable measures to ensure the realization of the objectives of this Contract.




H. SETTLEMENT OF DISPUTES**47. Amicable Settlement**

47.1 The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Contract or the interpretation thereof.

47.2 If either Party objects to any action or inaction of the other Party, the objecting Party may file a written Notice of Dispute to the other Party providing in detail the basis of the dispute. The Party receiving the Notice of Dispute will consider it and respond in writing within fifteen (15) days after receipt. If that Party fails to respond within fifteen (15) days, or the dispute cannot be amicably settled within fifteen (15) days following the response of that Party, Clause GCC 48.1 shall apply.

48. Dispute Resolution

48.1 Any dispute between the Parties arising under or related to this Contract that cannot be settled amicably within thirty (30) days after receipt by one party of the other Party's request for such amicable settlement may be referred to by either Party to the adjudication/arbitration in accordance with the provisions specified in the SCC.

I. BLACKLISTING**49. Blacklisting**

49.1 Without prejudice to any other right of the Client under this Contract, Public Procurement Monitoring Office may blacklist a Consultant for his conduct up to three years on the following grounds and seriousness of the act committed by the consultant.

- a) if it is proved that the consultant committed acts pursuant to GCC 22..2,
- b) if the Consultant fails to sign an agreement pursuant to Information to Consultants Clause 29.3,
- c) if it is proved later that the Consultant has committed substantial defect in implementation of the contract or has not substantially fulfilled his obligations under the contract or the completed work is not of the specified quality as per the contract,
- d) if convicted by a court of law in a criminal offence which disqualifies the consultant from participating in the assignment.
- e) if it is proved that the contract agreement signed by the Consultant was based on false or misrepresentation of consultant's qualification information,
- f) if the consultant fails to submit the professional liability insurance within the period stipulated in the contract.

49.2 A Consultant declared blacklisted and ineligible by the Public procurement Office, and or concerned Donor Agency in case of donor funded project, shall be ineligible to participation the selection process during the period of time determined by the PPMO, and or the concerned donor agency.



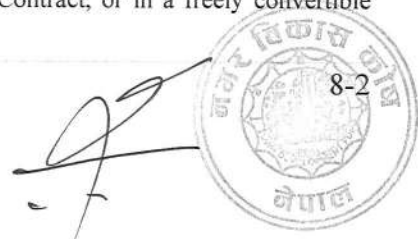
